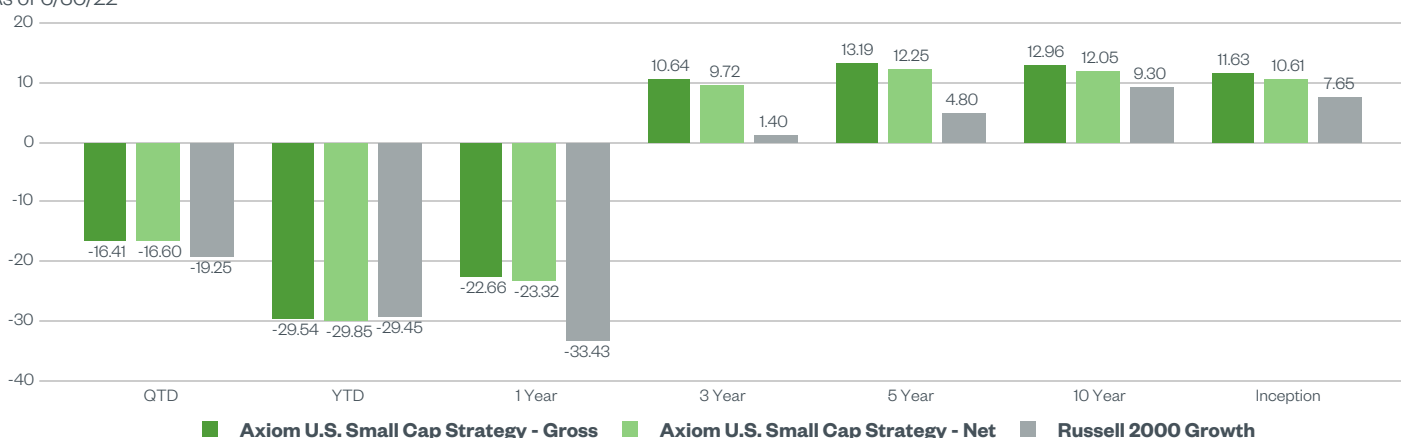

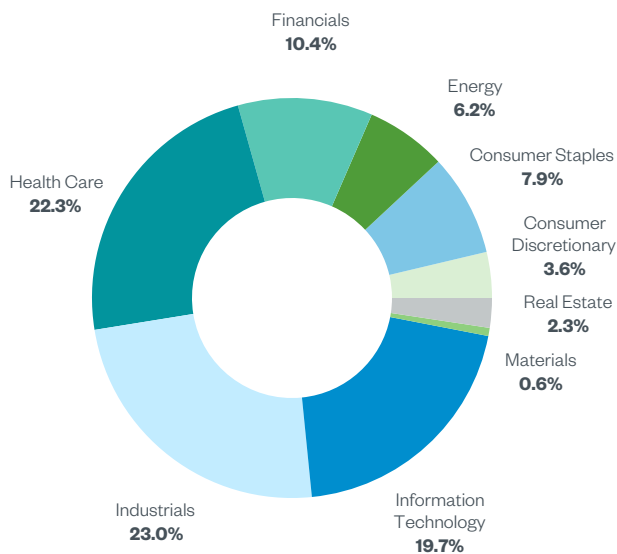

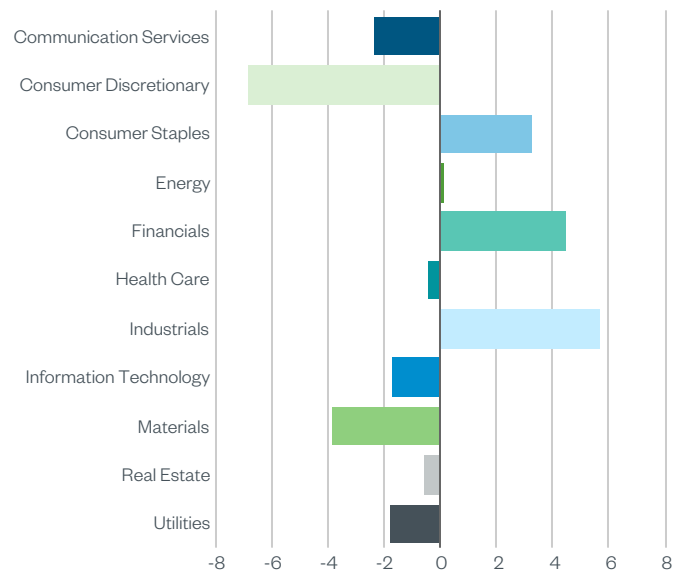

Commentary

During the second quarter 2022, the Axiom US Small Cap Equity Strategy ("Strategy") outperformed the Russell 2000 Growth Index ("Index") net of fees. The Strategy has outperformed the Index on a net of fees basis over 1-year, 3-year, 5-year, 10-year, and since inception periods.

Financial markets were broadly pressured during Q222 as more restrictive Federal Reserve Monetary policy, persistent inflation, moderating economic growth data, and continued supply chain / geopolitical tensions drove recession concerns. During the quarter, consensus US Real GDP forecasts were revised lower for 2022 from +3.5% to +2.5% and for 2023 from +2.3% to +1.9%. The Russell 2000 Growth Index suffered its worst quarter in history, declining -19.3%, and the -29.5% 1H22 decline for the Index was also the worst start to a year in the history of the index. Small Cap Growth companies underperformed Small Cap Value companies during the quarter by 400bps. This was the 7th consecutive quarter of small cap growth relative underperformance. Aside from staples, all sectors in the Russell 2000 Growth Index experienced double-digit corrections.

The best performing sector for the Strategy on a relative basis during the second quarter was health care, led by diagnostic medical imaging agent manufacturer Lantheus Holdings and behavioral healthcare services provider Acadia Healthcare. Industrials was also a source of relative outperformance driven by global business advisory firm FTI Consulting and Chart Industries, a global manufacturer of engineered equipment servicing energy and industrial markets. Financials was another notable area of relative outperformance driven by Kinsale - a specialty provider of excess and surplus insurance. The largest detracting sectors for the quarter included energy, materials, and information technology, where companies were impacted by rising global growth concerns.

From an individual stock perspective, the best relative contributors for the quarter were FTI Consulting, Lantheus Holdings, Acadia Healthcare, defense and aerospace technology vendor Mercury Systems, and Chart Industries. The largest detractors on a relative basis were fertility benefits provider Progyny, fertilizer manufacturer Intrepid Potash, digital business process outsourcer TaskUs, customer engagement software supplier Verint Systems, and full-service equipment rental provider Herc Holdings. These companies were negatively impacted during the quarter given tougher comparables, continued margin headwinds, and a more uncertain growth outlook.

Axiom continues to invest in dynamic growth stocks delivering superior growth and profitability. Market volatility has driven small cap valuations to historically attractive levels on an absolute and relative basis versus large caps. Earnings expectations remain encouraging for the Strategy, and we continue to carefully monitor company fundamentals into 2H22. COVID trends, the pace of economic growth, fiscal/monetary policy actions, and geopolitical risks will continue to result in periods of elevated volatility and uncertainty in equity markets. While we continue to closely monitor these events, our focus remains on fundamental, bottom-up investing in innovative, higher quality small-cap companies that are visibly and dynamically growing their revenues and earnings faster than prevailing economic growth rates. Well-capitalized, profitable, and reasonably valued growth companies that are executing in the current environment remain a differentiated and compelling area of investment.

Composite Description: The US Small Cap Equity strategy (the "Composite") is designed for investors who seek to invest in a broadly diversified portfolio of small cap equities. Portfolios are invested in smaller capitalization equity and equity-related securities in companies located within the United States. Currencies may be actively managed to reduce portfolio volatility. The Composite represents the performance of all Institutional small cap style fee-paying, discretionary equity accounts, regardless of asset size and comingled fund(s). The Composite was initiated and created in September 2006. As of January 1, 2022 the composite name changed from US Small Cap Equity Composite - IPO Eligible to US Small Cap Equity Composite. Prior to January 1, 2022 the composite only included accounts that were eligible to invest in Initial Public Offerings. A list of composite descriptions, a list of limited distribution pooled fund descriptions, a list of broad distribution pooled funds and performance results are available upon request.

Benchmark Description: The benchmark is the Russell 2000 Growth index, which is designed to measure the performance of the small cap growth segment of the U.S. equity universe. The benchmark is calculated on a total return basis and is free float-adjusted market cap weighted and unmanaged.

Significant Cash Flow Policy: Accounts with a cash flow greater than 20% of the portfolio market value are excluded for the month.

Reporting Currency: Valuations are computed and performance is reported in U.S. dollars.

Fees: Gross of fees returns are presented before management and custodial fees but after all trading expenses. Net of fees returns are calculated by deducting the highest fee from the monthly gross composite return which is expressed above in the stated fee schedule. Returns include the reinvestment of income. The fee schedule for the Axiom U.S. Small Cap Equity Portfolio, which is included in the US Small Cap Equity Composite is listed above. The total expense ratio as of December 31, 2020 was 0.61%. The Axiom U.S. Small Cap Equity Trust OIT, which is also included in the composite has an all-in fee (management fees & expenses) of 0.70%.

Internal Dispersion: Internal dispersion is calculated using the asset-weighted standard deviation of annual gross returns of those portfolios that were in the composite for the entire year. If 5 or less accounts, N/A is shown.

Annualized Standard Deviation: The three-year annualized standard deviation measures the variability of the composite gross returns and the benchmark returns over the preceding 36-month period. The standard deviation is not required for periods prior to 2011.
