
Objective





Commentary

During the second quarter 2023, the Axiom US Small Cap Equity Strategy ("Strategy") underperformed the Russell 2000 Growth Index ("Index") net of fees. The Strategy has outperformed the Index on a net of fees basis over 3-year, 5-year, 10-year, and since inception periods.

Small cap equities continued their recent trend of volatility in the second guarter, trading sideways in April and May as markets digested first quarter gains and debated future Federal Reserve policy actions versus economic growth uncertainties. The failures of Silicon Valley and Signature Banks earlier this year continued to raise concerns over second-order economic effects. The Russell 2000 Growth Index rose sharply in June on moderating inflation measures, broadly better than expected economic and employment data, which eased near term recession fears, and budding enthusiasm around generative artificial intelligence technologies. Given the more resilient economic data, US Real GDP growth expectations for 2023 were raised from +1.0% to +1.3%, but 2024 US Real GDP Growth expectations were lowered from +1.0% to +0.7% during the second quarter, reflecting continued growth uncertainties. Forward interest rate expectations similarly shifted, with expected interest rate cuts moving from the second half of 2023 into calendar year 2024. The Russell 2000 Growth Index returned +7.1% in the second quarter, versus the Russell 2000 Value Index +3.2% return. From a style perspective, small cap growth has outperformed small cap value over the last 2 quarters, signaling a potential for sustained change in market leadership.

From a sector perspective, the second quarter saw a significant dispersion in performance with health care +13.2% (biotech +18.5%) versus utilities -2.1%, reflecting a notable reversal in sector performance relative to the first quarter. In addition to health care, sectors that relatively outperformed the benchmark included industrials and consumer staples, while technology, energy, real estate, financials, consumer discretionary, telecom, materials, and utilities relatively underperformed.

The best performing sectors for the Strategy on a relative basis during the second quarter were financials, led by strong performance from Kinsale Capital, followed by materials, due to underweight exposure, and consumer staples, due to strong performance from e.l.f. Beauty on stronger than expected results and guidance. Information technology, industrials, and consumer discretionary were the largest relative detracting sectors.

From an individual stock perspective, the best relative contributors for the quarter were Inspire Medical Systems, e.l.f. Beauty, SPS Commerce. These companies saw continued strong demand coupled with effective cost management, leading to better than expected results and guidance. The largest detractors on a relative basis were Xponential Fitness, Impini, and Sprout Social. We continue to carefully monitor company fundamentals for these companies, where macroeconomic uncertainties led to disappointing guidance commentary relative to market expectations.

Axiom continues to invest in dynamic growth stocks delivering superior growth and profitability. While small cap growth stocks outperformed small cap value stocks during the quarter, there was notable relative underperformance in higher quality, lower volatility companies that presented headwinds to our investment style and reflected the continued sharp rotation away from factors that have relatively outperformed over longer-term time horizons. Earnings expectations remain encouraging for the Strategy, and we continue to carefully monitor company fundamentals into the second half of the year. COVID recovery trends, the pace of economic growth, fiscal / monetary policy actions, and geopolitical risks will continue to result in periods of elevated volatility and uncertainty in equity markets. Our focus remains on fundamental, bottom-up investing in innovative, higher quality small-cap companies that are visibly and dynamically growing their revenues and earnings faster than prevailing economic growth rates. Financially independent, profitable, and reasonably valued growth companies that are executing in the current environment remain a differentiated and compelling area of investment.

Composite Description: The US Small Cap Equity strategy (the "Composite) is designed for investors who seek to invest in a broadly diversified portfolio of small cap equities. Portfolios are invested in smaller capitalization equity and equity-related securities in companies located within the United States. Currencies may be actively managed to reduce portfolio volatility. The Composite represents the performance of all Institutional small cap style fee-paying, discretionary equity accounts, regardless of asset size and comingled fund(s). The Composite was initiated and created in September 2006. As of January 1, 2022 the composite name changed from US Small Cap Equity Composite -IPO Eligible to US Small Cap Equity Composite. Prior to January 1, 2022 the composite descriptions, a list of invest in Initial Public Offerings. A list of istribution pooled fund sand performanceresults areavailable upon request.

Benchmark Description: The benchmark is the Russell 2000 Growth index, which is designed to measure the performance of the small cap growth segment of the U.S. equity universe. The benchmark is calculated on a total return basis and is free float-adjusted market cap weighted and unmanaged.

Significant Cash Flow Policy: Accounts with a cash flow greater than 20% of the portfolio market value are excluded for the month.

Reporting Currency: Valuations are computed and performance is reported in U.S. dollars.

Fees: Gross of fees returns are presented before management and custodial fees but after all trading expenses. Net of fees returns are calculated by deducting the highest fee from the monthly gross composite return which is expressed above in the stated fee schedule. Returns include the reinvestment of income. The fee schedule for the Axiom U.S. Small Cap Equity Portfolio, which is included in the US Small Cap Equity Composite is listed above. The total expense ratio as of December 31, 2022 was 0.40%. The Axiom U.S. Small Cap Equity Trust CIT, which is also included in the composite has an all-in fee (management fees & expenses) of 0.70%.

Internal Dispersion: Internal dispersion is calculated using the asset-weighted standard deviation of annual gross returns of those portfolios that were in the composite for the entire year. If 5 or less accounts, N/A is shown.

Annualized Standard Deviation: The three-year annualized standard deviation measures the variability of the composite gross returns and the benchmark returns over the preceding 36-month period. The standard deviation is not required for periods prior to 2011.

Batting Average: The number of periods that the portfolio outperforms (or matches) the benchmark divided by the total number of periods.

Tracking Error: The active risk of the portfolio. It determines the standard deviation of the excess returns between the portfolio and the benchmark. It is calculated by creating a new return series of the excess returns and then calculating the population standard deviation of that return series.

Information Ratio: A measure of consistency in excess return. The annualized excess return over a benchmark divided by the annualized standard deviation (population) of excess return.
